## ecover terms of use

**By registering for an ecover account you agree to these Terms of Use**, which set out the terms on which ecover is provided. If You do not agree, You must not use ecover.

We (**Coverforce Underwriting Pty Ltd**) may at any time and for any reason, by notice to You by email, terminate this Agreement, or suspend or terminate Your account. If so, Your account will be disabled, You will have no access to and no right to use ecover or any files, or other information contained in Your account although residual copies of information may remain in our system.

**You must:**

- (a) provide current, accurate identification, contact, and other information that may be required as part of the registration process or continued use of ecover;
- (b) ensure the security of Your use of ecover and maintain the confidentiality of Your password and ecover account;

**You must not do, and You must not authorise or encourage any third party to do, any of the following:**

- (a) prevent other ecover account holders from using ecover;
- (b) use ecover for any illegal, fraudulent or inappropriate purpose, including copyright infringement, spam, breaches of privacy, defamation;
- (c) interfere with or construct Your own system to access the information on ecover; or
- (d) act in any way that violates this Agreement.

**You acknowledge and agree to each of the following:**

- (a) ecover is only provided to You for so long as You continue to have a current and valid ecover account;

- (b) ecover may be subject to technical limitations and due to the nature of ecover, We do not promise that it will be continuous, accessible at all times or fault-free;

- (c) ecover is provided on an AS IS and AS AVAILABLE basis and We make no warranties or guarantees in respect of availability. You use ecover at Your own risk. We do not assume ANY responsibility for, without limitation, backing up Your data or damage to or integrity of Your data;

- (d) We own all rights in and to ecover, including without limitation all intellectual property rights. You must not copy, reproduce, alter, modify, reverse engineer or create derivative works from ecover. You must not use any robot, spider, other automated device, or manual process to monitor any content from, hosted by or that is otherwise available using ecover.

**To the extent permissible by law We exclude any liability:**

- (a) for any failure of performance, error, omission, interruption, deletion, defect or delay in transmission or operation, or
- (b) for any injury, loss or damage arising out of provision of ecover,

provided that We do not exclude any such liability if it arises as a result of Our failure to take reasonable steps to guard against and use its best endeavours to immediately rectify any of the matters referred to in this clause of which We are aware.
